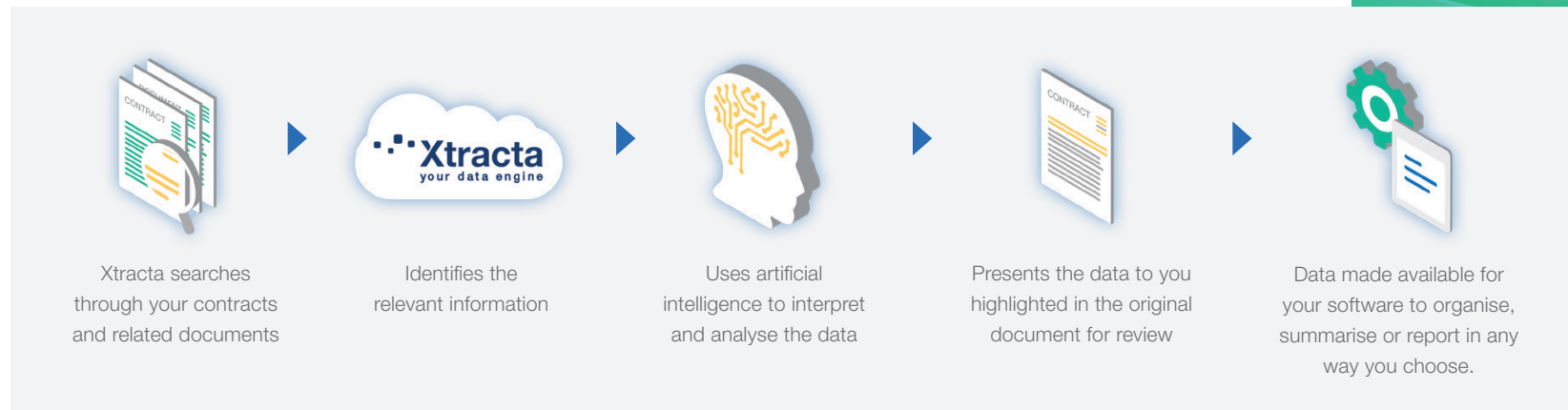

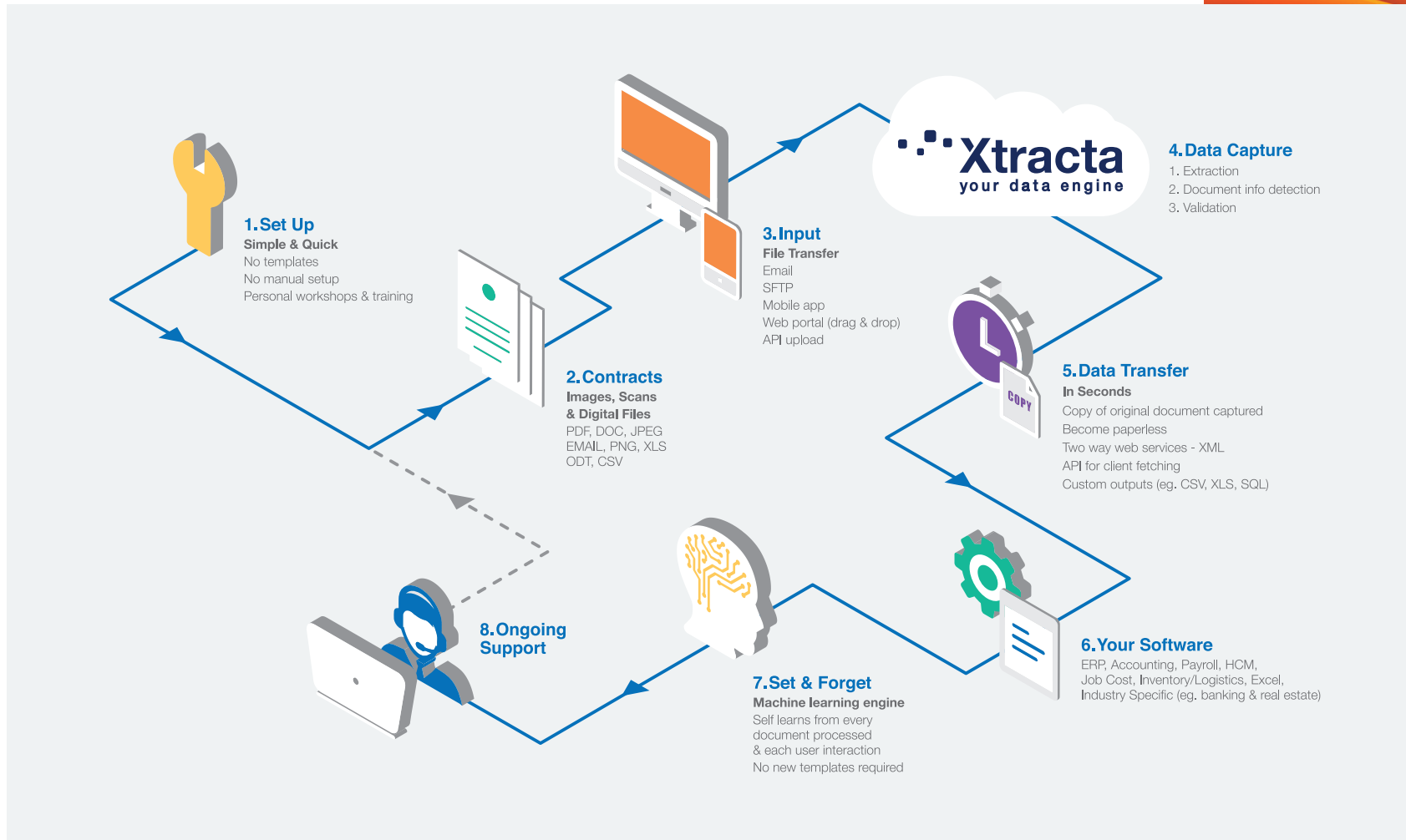
  - **Detect the similarities and differences between documents** such as employment contracts for comparisons.

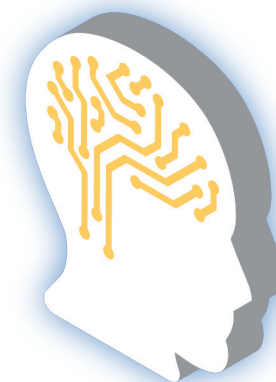

## Xtracta - The smarter data capture engine

**At the heart of the Xtracta engine is artificial Intelligence which empowers the system to understand, learn and continually better itself without any coding or upgrades.**

Machine learning allows the engine to constantly learn with every new legal document scanned and every interaction with your team. This self-learning ability enables data to be captured from any number of contract designs and in a variety of languages and currencies.



### Key Functions Xtracta Provides

- Identification of relevant areas of a document where data needs to be captured from e.g. find and highlight all areas related to “termination”. Xtracta also provides a simple to use user interface that users can switch between these highlighted areas to process the documents.
- Capture specific values from the contract (e.g. similar to invoice data capture).
- Read and interpret multiple pieces of logic used to reach conclusions either explicitly stated within the document (but that would be found through interpreting logic such as references between sections, definitions etc.) or that are simply known results that are not explicitly stated in the document but can be concluded based on the logic.
